Technical Analysis is the study of Investor behavior & its effect on the subsequent price action of Financial Instruments. There are many ways to display price charts. Each has its own benefits, but at the end of the day it is up to the individual to decide which provides the clearest visual picture and is likely to be of most help in identifying trends at an early stage. Charting as an interpretation tactic is typically used more readily in the Currency & Commodity markets where liquidity is good & a lot of relatively short term decisions are made by participants. Nevertheless, once understood as a guidance tool, it is quite readily employed across any Financial market
